**Official Rules**  
**Aug. 24, 2015 – Sept 19, 2015**

**1. Eligibility:** Contest is open to all legal residents of Utah, eighteen (18) years of age and older at the time of Promotion Aug. 24, 2015 – Sept 19, 2015, except as noted below. No purchase necessary to enter or win. Employees of Ogden Publishing Corporation, (Standard-Examiner), any entity connected with the sponsorship or management of the contest, as well as members of the same household of any Standard-Examiner employee, are ineligible to participate.

Fill out the form in its entirety and submit. A contestant can nominate themselves and/or be nominated by a friend or family member any number of times. The objective is to nominate yourself or another deserving bride or couple to win a free wedding based on merit. If you are a future bride or have a special future bride in mind, write us an essay explaining "Why you/your candidate deserves to win this contest and why it would mean so much," and you or your candidate will be entered to win a wedding of a lifetime at Tuscany Gardens. In your essay, detail why you should, or your candidate should win in order to make your submission stand apart from the rest. Judges will base their decision on the amount of compelling content, images, examples and documents provided.

**3. Winner Selection & Contest Deadline:** PROMOTION begins Aug. 24, 2015 and ends Sept 18, 2015 at 5 PM MST. Only one winner/engaged couple per household is eligible to win. The decisions of Standard-Examiner are final and binding in all matters related to contest. The Standard-Examiner may elect to restrict or extend promotion dates and/or any other provisions of the contest without notice. All essays must be submitted no later than midnight on September 9, 2015. The Top 3 finalists will be chosen by a panel of judges and announced by September 11, 2015. From September 11 - September 18 the Top 3 finalists will use social media and the Standard-Examiner events website to gain votes for their entry. The candidate with the most votes will win.

**4. Prize is valued at \$4,500. Prize will be made in the form of a Tuscany Gardens Certificate.
